## **2023 Grant Application Guidelines**

### **St. Martin's Grant Giving Mission Statement**

The mission of outreach at St. Martin's Episcopal Church is to model the love of Christ by helping the underserved, the disadvantaged, and others broken by life's circumstances. While providing immediate needs such as food, clothing and shelter, St. Martin's outreach also supports organizations that provide service, emotional and spiritual support. Funding is targeted toward Christian programs in the greater Houston area and beyond, particularly those with opportunities for our volunteers to build relationships through hands-on involvement.

### **St. Martin's Episcopal Church Priority Funding**

St. Martin's gives priority to ministries that have many or all of these characteristics:

- Are Faith based,
- Bring about systemic change for children, families, disadvantaged and underserved
- Provide basic needs such as food, clothing and shelter or the means to provide basic needs for oneself
- Have St. Martin's member involved

### **St. Martin's Episcopal Church Does Not Provide Grants for:**

- Individuals
- Testimonial dinners, fundraising events, marketing events or symposium
- Political purposes either directly or indirectly
- Government agencies
- Fraternity or sorority purposes,
- Other grant making entities, for example "pass-thru" companies
- Coverage of past operating deficits or debts
- Seminary funding
- Capital funding

## Types of Support

Grants made for the following purposes:

- Project or program support,
- Matching grant,
- Capacity building grant to further expand an agency's effectiveness,
- Evangelism,
- Physical, mental and emotional well-being of the underserved,
- Addressing hunger needs
- Collaborative effort funding
- Doesn't exclude general operating funds, but prefers project/areas that are measurable

## Eligibility

St. Martin's Episcopal Church makes grants to nonprofit, tax-exempt organizations. St. Martin's awards grants only once a year and considers only one application from an organization within a calendar year. Former grant recipients who have not timely submitted acceptable progress reports shall not be eligible for funding in the current year.

## Grant Application, Deadlines, and Process

**All agencies seeking a grant award must be sponsored by a St. Martin's member in good standing. Between December 7, 2022 and January 24, 2023 at 12:00, please email [grants@stmartinsepiscopal.org](mailto:grants@stmartinsepiscopal.org) to request a 2023 Letter of Intent Application. All Letter of Intent Applications will require a Member (21 years or older) signature excluding St. Martin's Episcopal Staff members and members of the Grant Discernment Committee.**

Letters of Intent Applications are due to [grants@stmartinsepiscopal.org](mailto:grants@stmartinsepiscopal.org) by January 25, 2023 before 12:00Noon. 2022 recipients to fill 2022 Grant Follow Up Form to include with Letter of Intent Application for complete applications.

Agencies invited to the grant application phase will be notified on February 2, 2023. Applications will be emailed along with notification.

**No email applications/documentation will be accepted.** One application and attachments will be submitted between February 3, 2023 and February 15, 2023 before 3:00 pm. Application/attachments can be accepted by St. Martin's Episcopal Church Receptionist office only or mailed to:

Applications must be *received* At St. Martin's by February 15, 2023 by 3:00pm. Applications that do not follow the requirements will not be considered.

Between April 1st and September 1st, a grant reviewing committee member will contact the agency to schedule a site visit.

By November 15<sup>th</sup> all applicants will be notified in writing about any action taken by St. Martin's Episcopal Church. If a grant is awarded, a check will be mailed by November 15, 2023.

## **Grant Follow Up Form**

By January 25, 2023 each 2022 grant recipient will submit a report describing the process made and/or milestones achieved in furtherance of the purposes of the grant. Report is due with the Letter of Intent Application for 2023 in order to have a complete application for 2023. ## **Commitment to Informed Grant-making**

St. Martin's performs due diligence on all grant applicants to ensure the organization is an effective and healthy nonprofit organization. St. Martin's takes into consideration not only the written application, but also the results of telephone interviews and site visits. After a grant is awarded, grantees are required to provide documentation about the project's fulfillment/completion.

## **Not All Projects Can Be Funded**

St. Martin's Episcopal Church has the responsibility for the final approval of each grant. Since St. Martin's Episcopal Church receives funding requests that far exceed our grant budgets, we cannot fund every worthy project. A decision not to fund a proposal does not reflect on the merits of the proposal or the applicant's organization.
